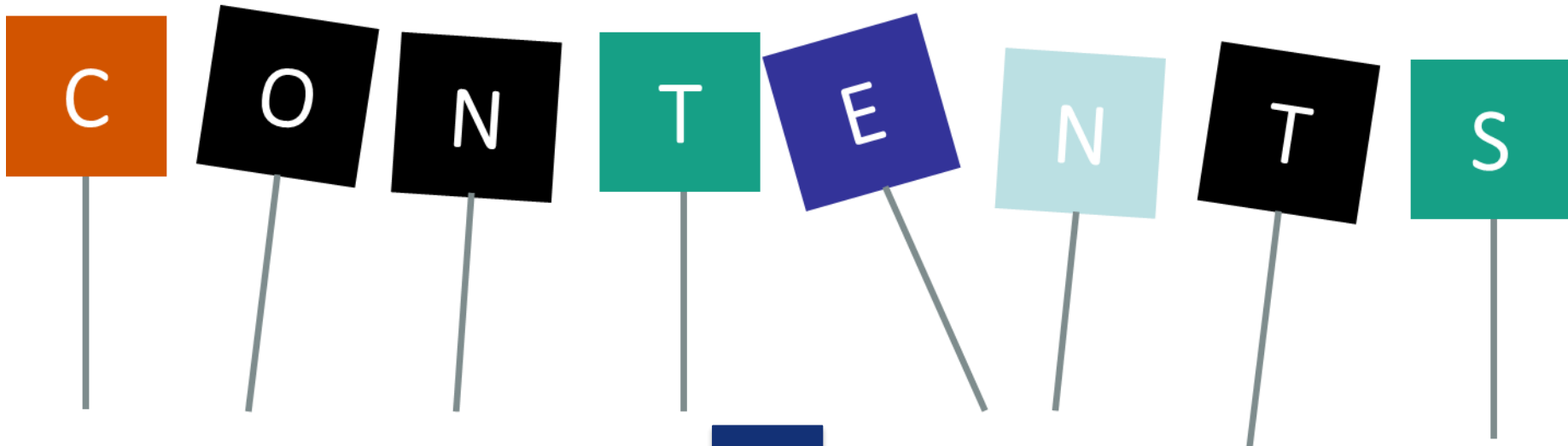

TERCET – a proposal of the Commission to include a number of territorial typologies into the NUTS Regulation

- The NUTS regulation amended at the end of 2017
- Will be updated annually
- Available in all official languages

Territorial typologies at LAU-level:

Degree of urbanisation (DEGURBA)

- Urban areas
 - 'Cities' or 'Densely populated areas'
 - 'Towns and suburbs' or 'Intermediate density areas'
- 'Rural areas' or 'Thinly populated areas'

Functional urban areas (FUA)

- Cities
- Commuting zones

Coastal areas

- Coastal areas
- Non-coastal areas

Urban/rural typology

- Predominantly urban regions
- Intermediate regions
- Predominantly rural regions

Metropolitan typology

INTRODUCTION

What do statistics on regions and cities tell me?

National figures alone cannot reveal the full and sometimes complex picture of what is happening at a more detailed level within the European Union (EU). In this respect, statistical information at a subnational level is an important tool for **highlighting specific regional and territorial aspects**. It helps in analysing changing patterns and the impact that policy decisions can have on our daily life.

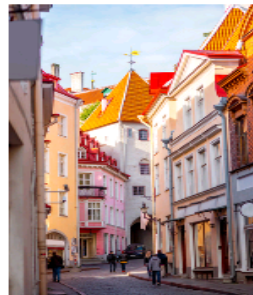
What kind of information is available?

In order to provide a detailed picture of the diverse EU territories and to monitor EU regional policy targets, Eurostat has developed a range of statistics based on **different classifications and typologies**. These include data for:

- regions,
- cities and greater cities,
- metropolitan regions,
- rural areas and regions.

Specific geographies such as coastal regions, mountain regions, border regions or island regions are also covered.

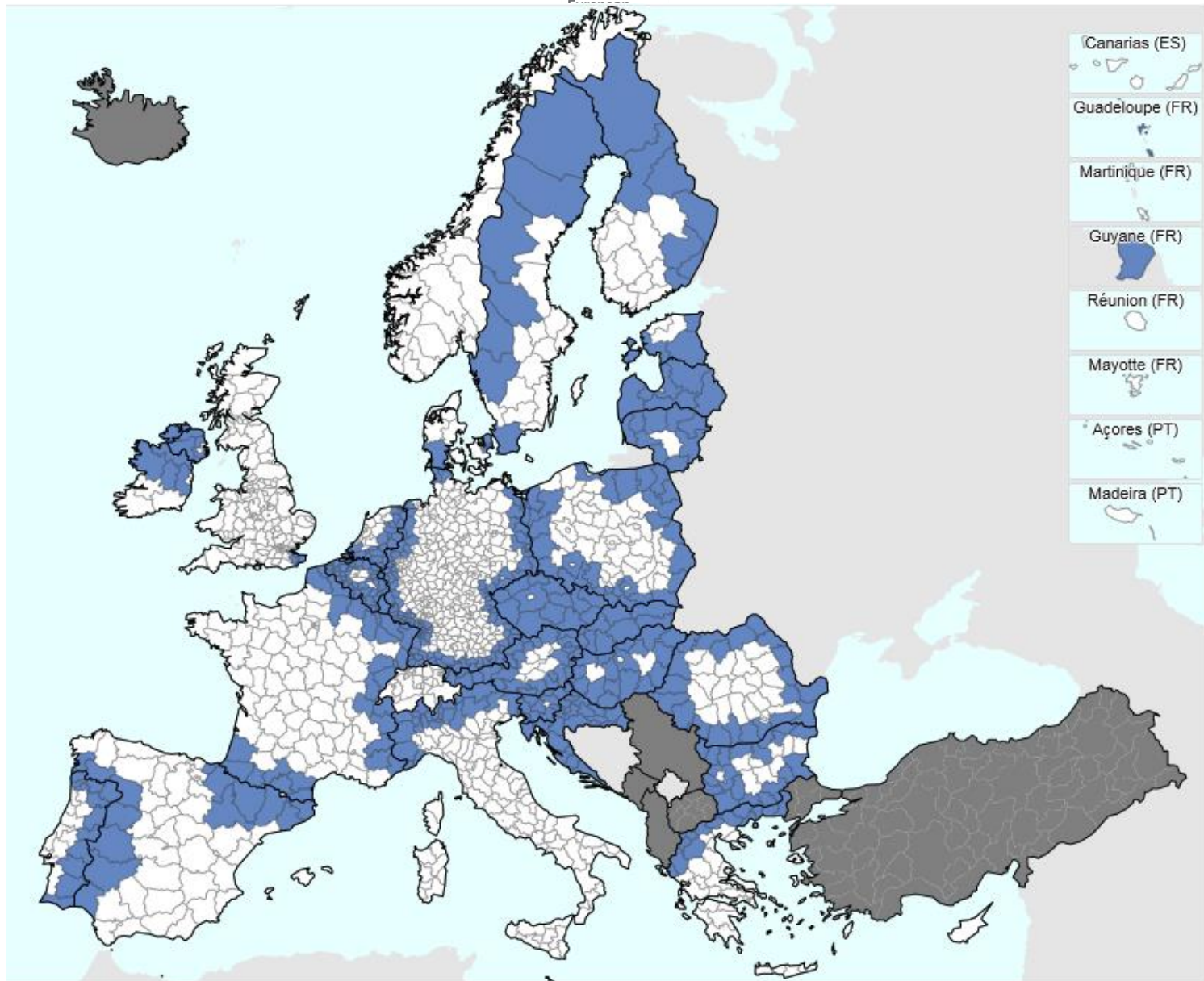

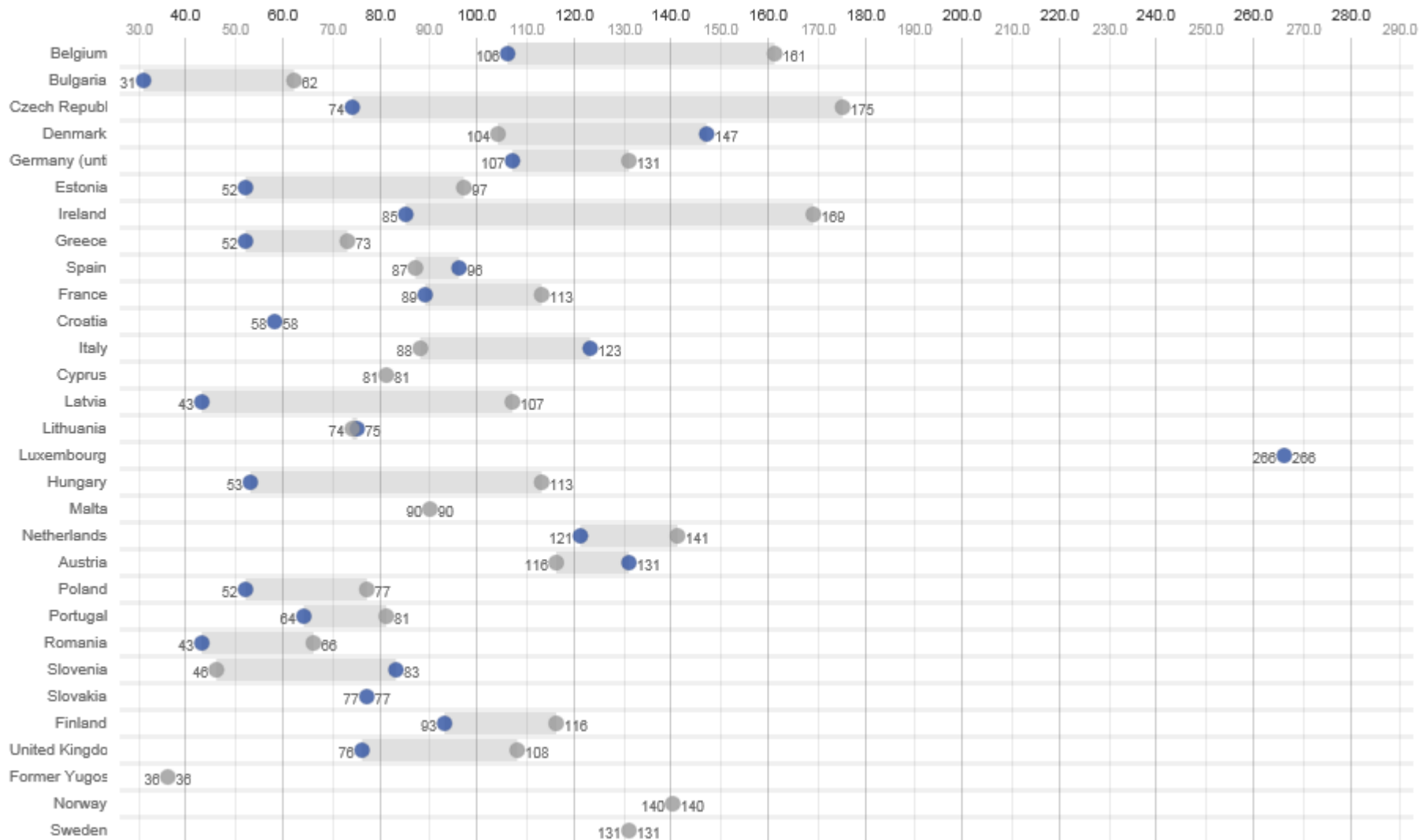

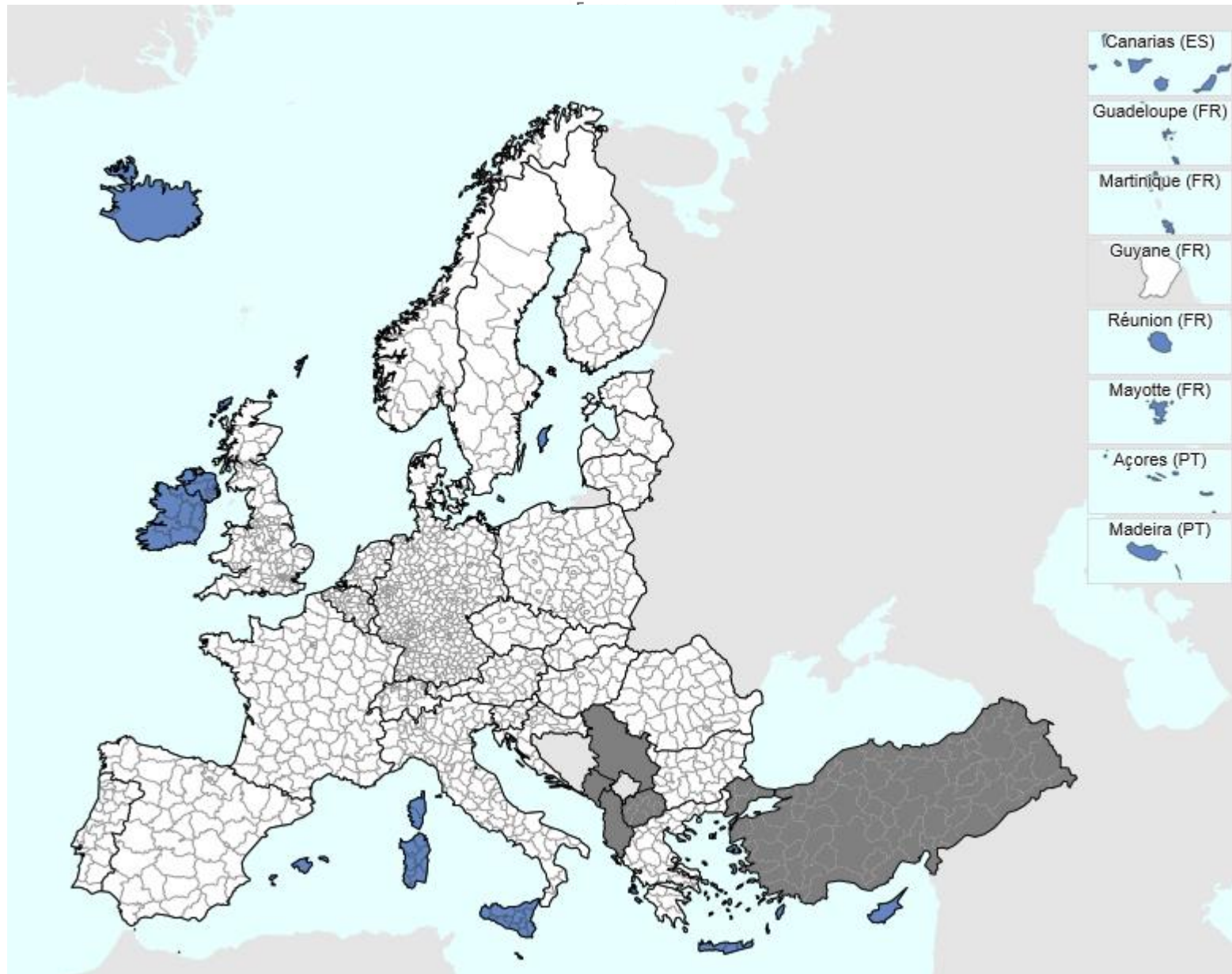

Purchasing power per inhabitant in % of the EU average, by aggregates of border and non-border regions, 2014

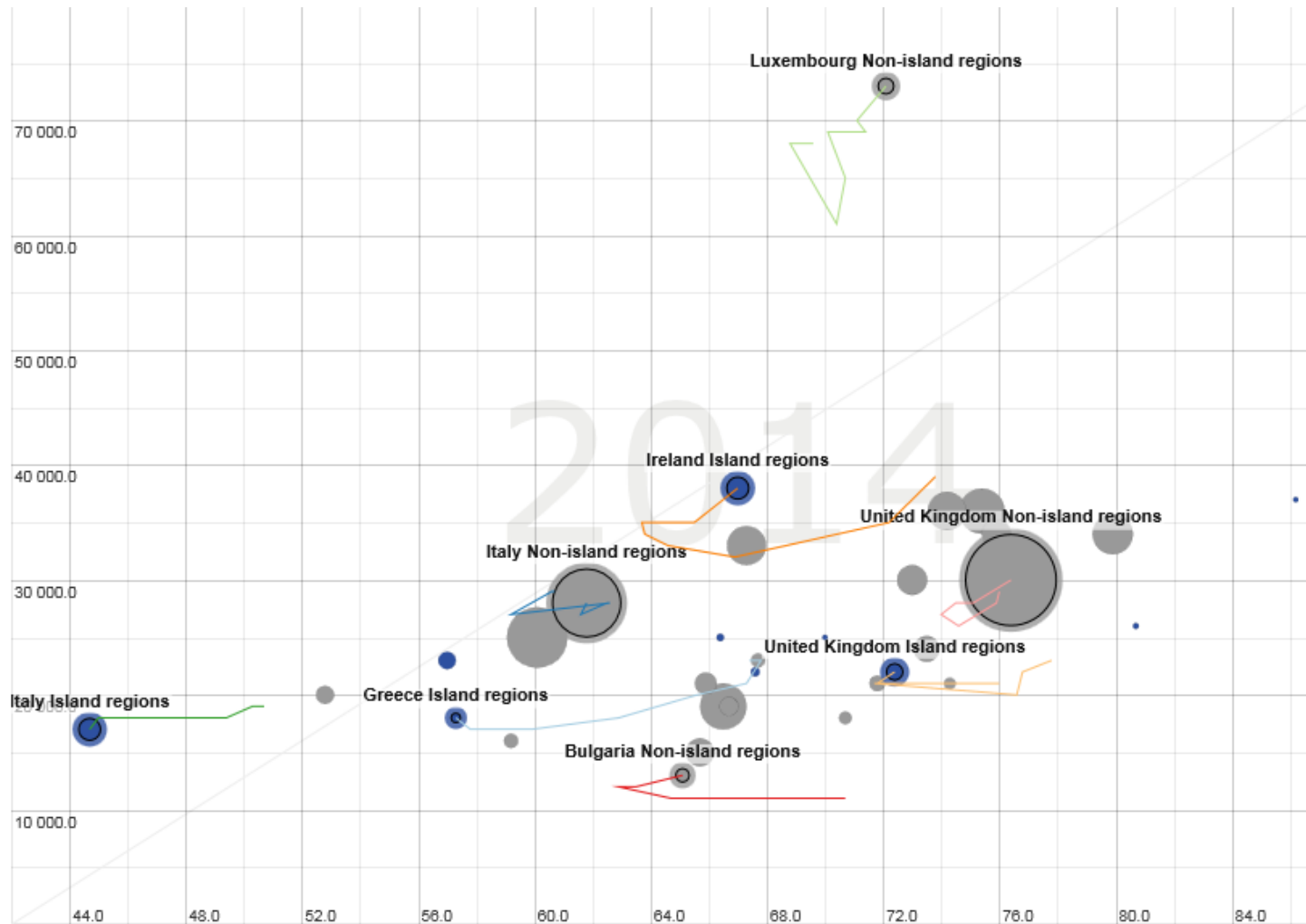

standard per inhabitant

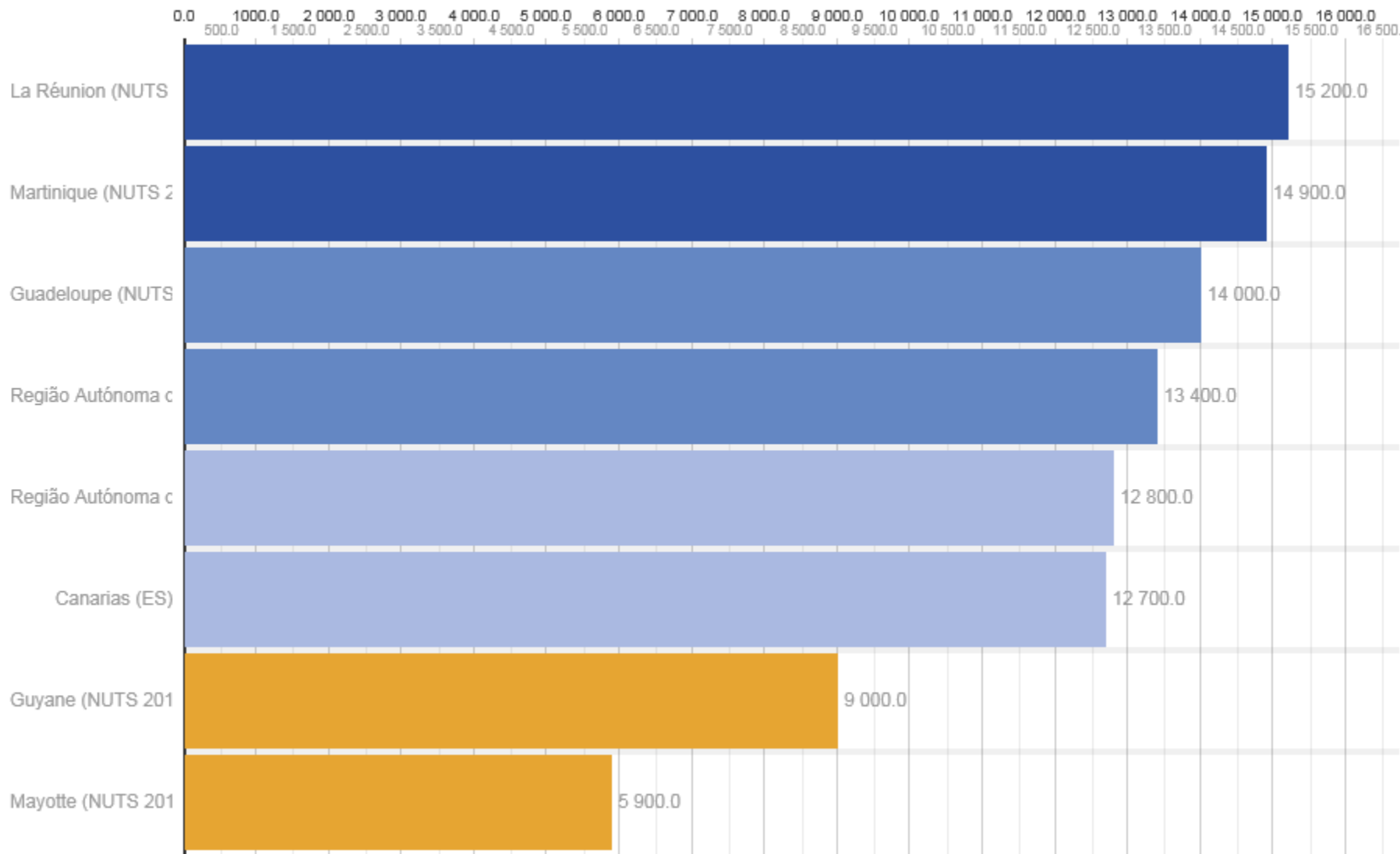


Employment rate, 20-64 years

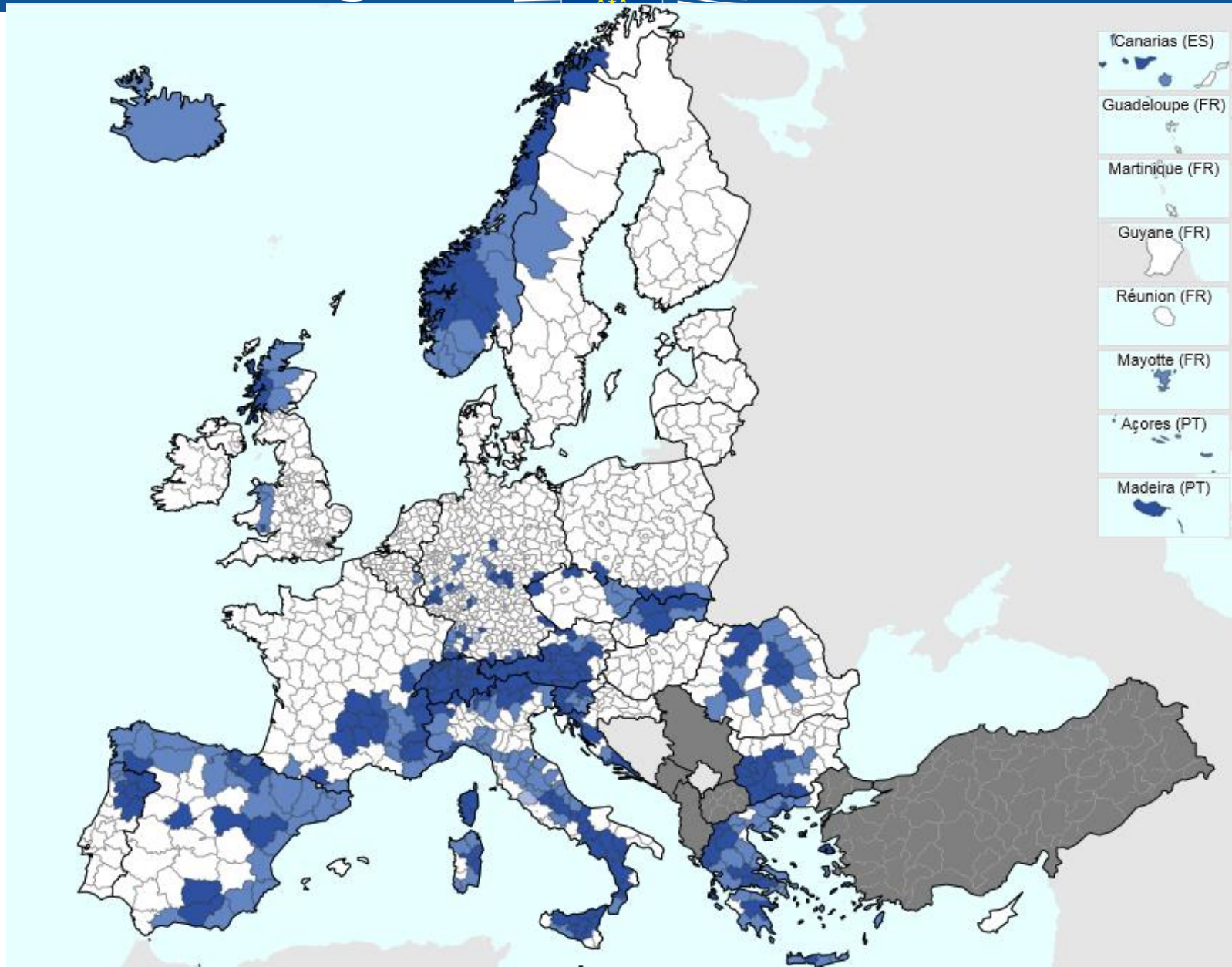

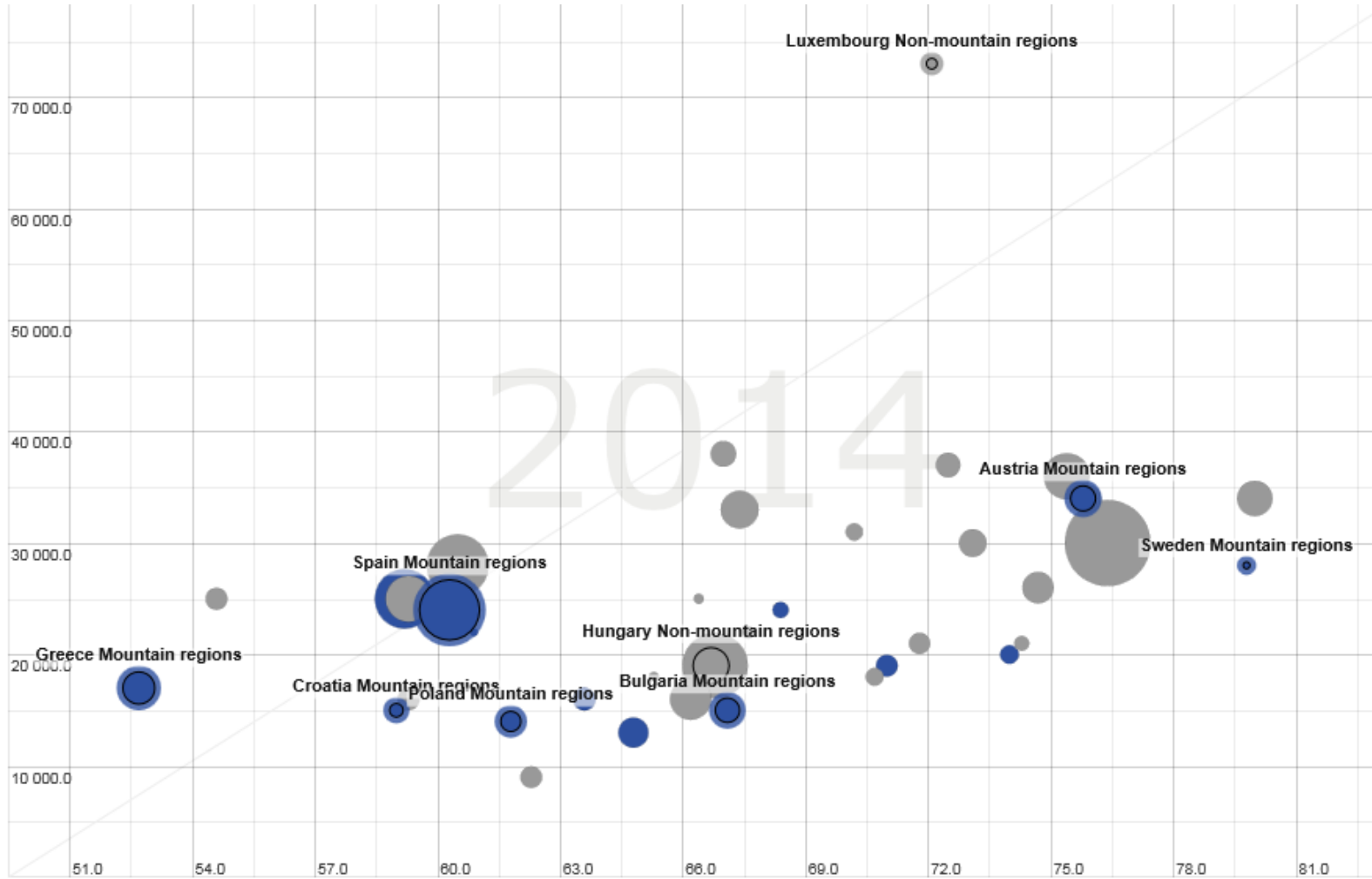

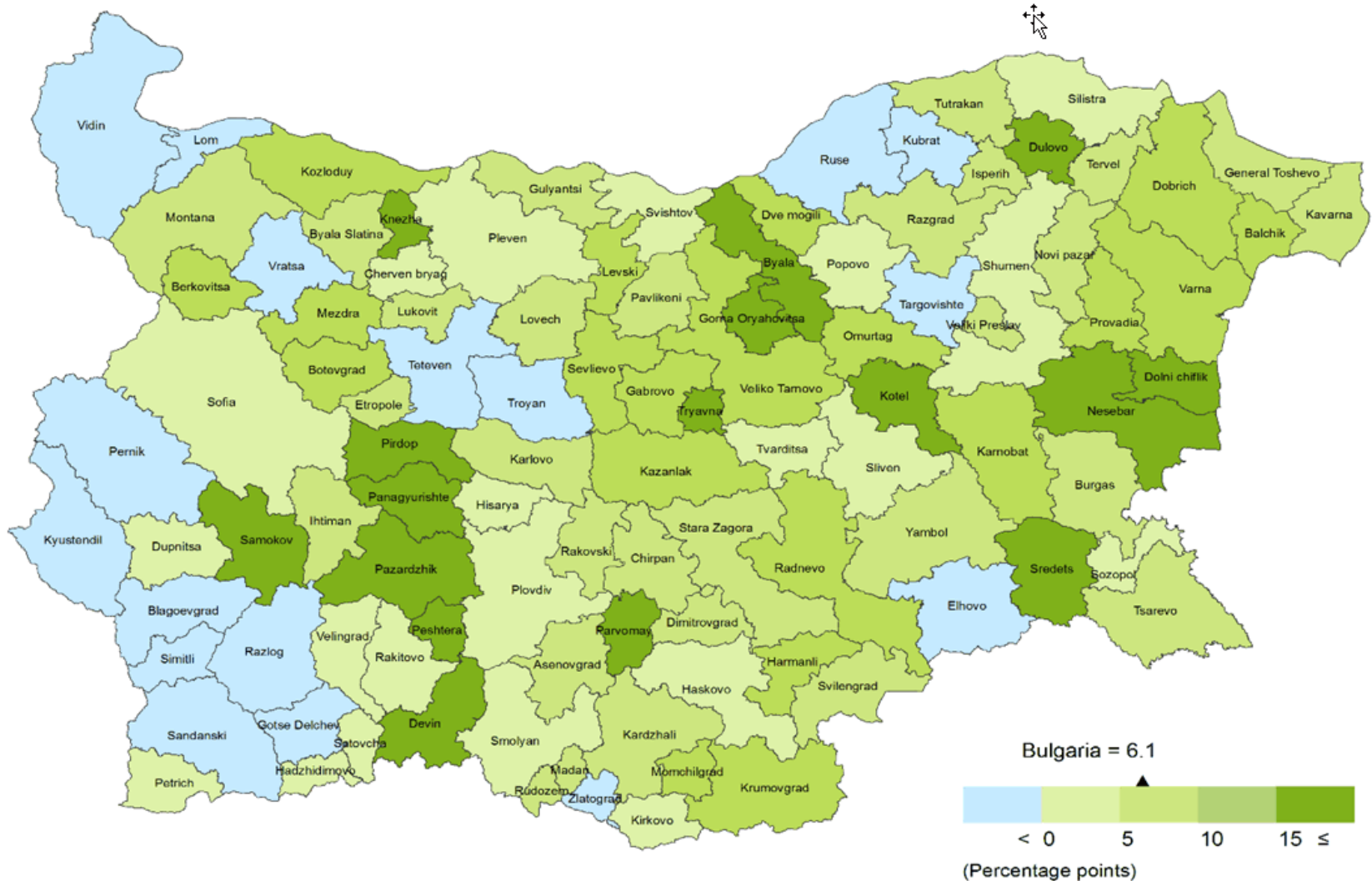
The concept of European harmonised Labour Market Areas

- A LMA is an agglomeration of municipalities where the majority of people live and work
- A common project between Eurostat and the MSs aiming at new EU dataset with full coverage
- National and EU scale to fit to different perspectives
- National and cross-border LMAs

Gender gap for the employment rate (15-64) by LMAs in 2015

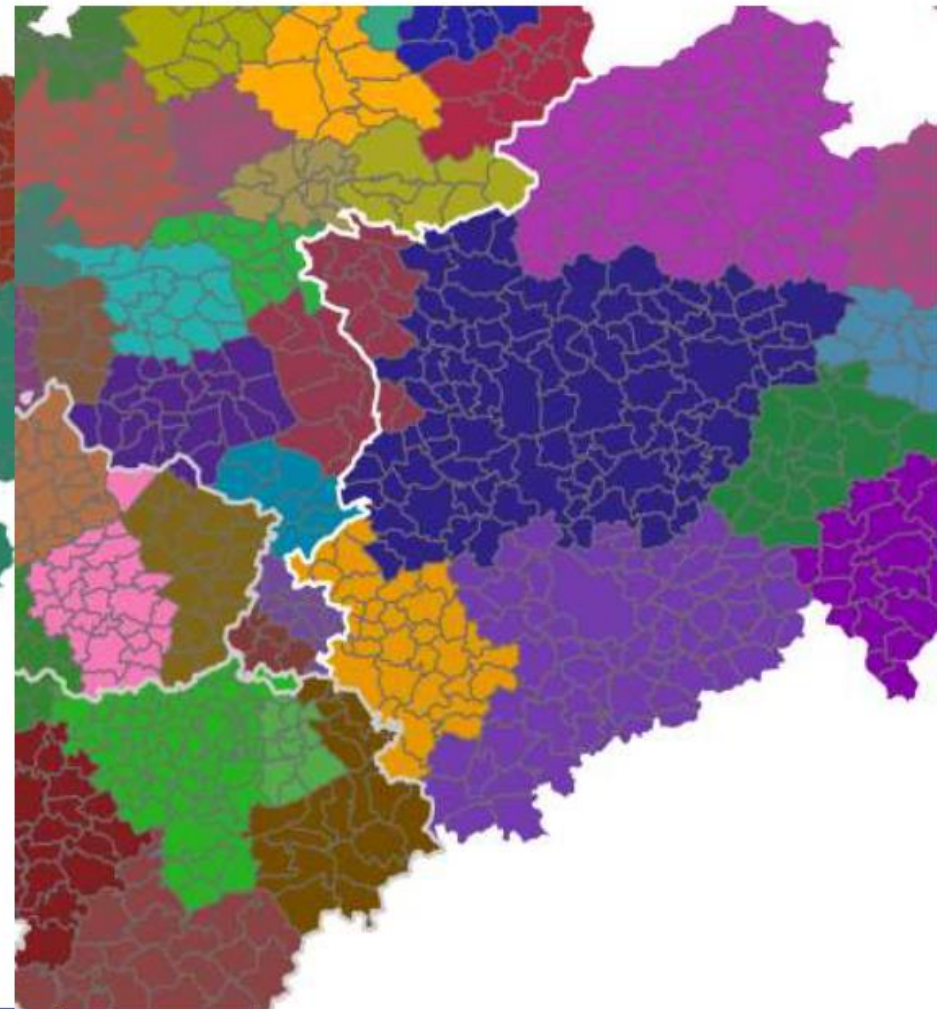


Cross-border LMAs – the Dutch experience
