Introduction

1.1

Objective and methodological approach

The objective of the Annual Work Plan (AWP) 2019 is to define the nature and the fields of TNO intervention and to set the framework for action in each of the 4 transnational groupings in support of the strategic policy processes in the ESPON Member States.

The proposals herein are based on a multi-step methodology summarised in Fig. 1.



Step 1

An update of the needs assessment was conducted in March 2018, collecting insights from the ECP network relating to policy processes that can benefit from ESPON research.

Step 2

The extent to which these processes can be served by TNO activities in 2019 was determined by examining the current and anticipated availability of relevant ESPON research outputs.

Step 3

The processes that can be served with evidence were assessed against the TNO activities carried out in 2017 and 2018 in an effort to filter the ones insufficiently addressed or not addressed at all (Table 1).

Based on step 3, the policy processes were grouped in 6 priorities for 2019 (Table 1). Policy priorities from 2017 and 2018 were not excluded from the outreach plan 2019 because of their multiannual nature (Table 2). These policy themes can be served horizontally under each of the 6 priorities, depending on the specific needs in the Member States.



In a fine-tuning step, processes which can be served under more than one priority have been ascertained. In chapter 3, events designed to serve either single-priority or multi-priority processes have been marked accordingly (Fig. 2).



In summary, the current document proposes to address the priorities ascertained for 2019 by means of:

- 2 Conferences;
- 2 Seminars;
- 3 Workshops;
- 5 trainings;
- 2 e-learning sessions.

The above programme will be accompanied by shorter documents and posters, which are to be decided on the basis of the transnational demand.

1.2

Quality Management and continuous improvement

In order to attain higher levels of satisfaction with and use of ESPON evidence at transnational, national and subnational scales, the TNO team will be developing, preparing and evaluating the activities in 2019 based on a recurring PDCA (Plan-Do-Check-Act) cycle. Lessons learnt from activities previously carried out as well as the feedback from the ECP network will be assimilated into the cycle when planning, implementing and evaluating every single activity.

1.2.1

Sound and timely preparation (Plan)

Following to the feedback to and lessons learnt from the past TNO activities, which are reflected in the 'TNO Annual Report 2017' (Deliverable 1.6), a particular attention will be given to the preparatory steps, and all necessary arrangements revolving around events will be planned and initiated well in advance in order to ensure the availability of competent experts and a high turnout. The shorter documents relevant for a particular event will be finalised at least one week in advance in order to ensure their distribution during the events. Table 7 (annex) proposes an indicative timetable for all preparatory steps and follow-up measures related to a particular activity.

Stakeholder engagement begins with the planning process. Consultation of individual experts and representatives of all target groups in the run-up to a certain activity is an outreach measure by itself, whose value and relevance for the overall outreach results shall not be neglected. The lessons learnt show that this reasoning does not only play a role for the quality of the activity and consequently for the satisfaction with and use of ESPON evidence. A customer and result-oriented approach of experts and representatives of target groups (i.e. policy makers at different tiers of governance) engenders ownership and a voluntary multiplier effect. The TNO team will, therefore, continue to apply and improve the individual fine-grained needs assessment measures before every activity so as to ascertain the expectations towards ESPON at transnational, national and subnational scale. This is a prerequisite for both the event programme and composition of speakers. The relevant experts to be involved as speakers will be invited, contracted and briefed well in advance in order to allow for an adequate customisation and contextualisation of normative messages.

In addition to the content-related design, the TNO team is in charge of all organisational and logistical matters. The relevant ECPs will be kept informed about the progress and will be invited to share their opinion on proposals. Any remarks or particular needs from the ECPs (e.g. the need for interpretation) will be addressed by the TNO, which can imply new logistical, organisational and content-related proposals to be made and arranged by the TNO team alone.

1.2.2

Bringing ESPON closer to stakeholders (Do)

The activities proposed in this work plan are a unique opportunity to enhance the involvement of and stimulate interaction between stakeholders at transnational, cross-border, national and subnational levels. To do so, the TNO team will engage in efforts to bring ESPON closer to the relevant stakeholders. This ambition has several implications. Depending on the demand, simultaneous interpretation will be offered. The same applies to shorter documents, which can be made available in the respective national language(s) upon consultations with the ECP network. Moreover, the TNO team will involve speakers and moderators which are most suited for a certain context and most likely to engage in a context-relevant dialogue with both the audience and fellow-speakers. Finally, in response to specific demands and expectations, context-relevant formats and engagement methods will be applied so as to allow for a stimulating experience.

The ESPON activity does not end with the event. While bringing context-relevant recommendations, the activities will not be limited to one-sided normative messages. For the best outcome, every activity seeks to stimulate discussion and bring in a multi-layered expertise to a discussion. The conclusion as to how a certain recommendation relates to a certain context can only be reached through dialogue with the concerned stakeholders. These conclusions can be relevant for other stakeholder groups – those who could not attend or stakeholders from other territorial contexts where these conclusions can be extrapolated. Therefore, conclusions will be communicated through follow-up activities including articles and dissemination measures using relevant channels.

1.2.3

Evaluation of the activities (Check)

Following every event, the TNO team will survey participants with regard to both the event and the shorter document (where applicable). The aim of the survey will be to elicit quantitative and qualitative data about both the effectiveness of the TNO activity and the participant's satisfaction, but also about the usability of applied research, targeted analyses, policy briefs, working papers and tools. The relevant ECPs will be invited to share their opinion on both the implementation and content.

1.2.4

Implementation of lessons learned (Act)

Both the results from the survey and possible feedback from the ECPs will be examined, conclusions drawn and new improvement measures carried out for every subsequent TNO activity.

- How can flexible collaborative governance leverage post-2020 public investments in functional areas?
- How can green infrastructure be integrated into the development policies of Central European functional areas? How can green infrastructure improve welfare in Central European functional areas? To what extent is green infrastructure rewarding from an economic point of view in Central European functional areas?





Description of the event

This event will be composed of two parts:

Part 1

This part will support the finalization of the new Spatial Planning Strategy in The Netherlands, notably the identified challenges related to competitive and circular economy and the transition to renewable energy and climate adaptation. It will provide answers to the following policy questions:

- What territorial factors influence the development towards a circular economy?
- How do the approaches used to implement a circular economy, such as industrial symbiosis, clustering, territorial connectivity, energy efficiency and smart logistics, but also the sharing economy, affect different types of regions and cities?
- What is the potential for implementing the circular economy in Dutch regions and cities and what kind of action/policy is needed to ensure a smooth transition to circular economy/lifestyle?
- Are there particular types of Dutch regions that find it easier in making full use of their renewable energy potential? How can existing challenges in this context be overcome in different types of territories?
- What kind of actions/policies are needed to ensure a smooth transition to a low-carbon economy/lifestyle?
- What framework conditions can regions and cities create for unlocking low-carbon investment by the private sector?
- What are the territorial distribution patterns of low-carbon SME in Western Europe in general and The Netherlands in particular?
- What has been the role of ESIF-based financial instruments applied in Western Europe in general and The Netherlands in particular in the MFF 2007-2013 in terms of sustainable investments?

Part 2

Involving stakeholders from the roadshow regions, this part will provide conclusions about new challenges and solutions in West European spatial planning. It will tie in with part 1 of the conference by integrating the thematic focus presented above into a value chain of territorial issues, which concern spatial planners from France, Ireland, Belgium, Luxembourg and the Netherlands, and had been individually discussed in the previous editions of the roadshow. Spatial planners are confronted with unprecedented challenges related to climate change, growing complexity of the morphological and functional interrelations of territorial units compounded by territorial polarisation (i.e. territorial isolation on the one hand and excessive unsustainable land use on the other hand) as well as conflicting social, economic and environmental interests that cause negative externalities with territorial ramifications. Part 2 will revolve around a value chain of solutions related to 1) cross-sectoral planning reconciling the green economy with social and economic interests in spatial planning; 2) the shift from a traditionally institutional and normative territorial governance culture in static administrative units to an open, shared and responsive one in functional areas; 3) sustainable land use and 4) effective use of financial instruments in the implementation of a new planning culture.

Furthermore, the session will seek to ascertain the common spatial planning research needs in Western Europe that can be addressed by ESPON in future.


Aim of the Event
