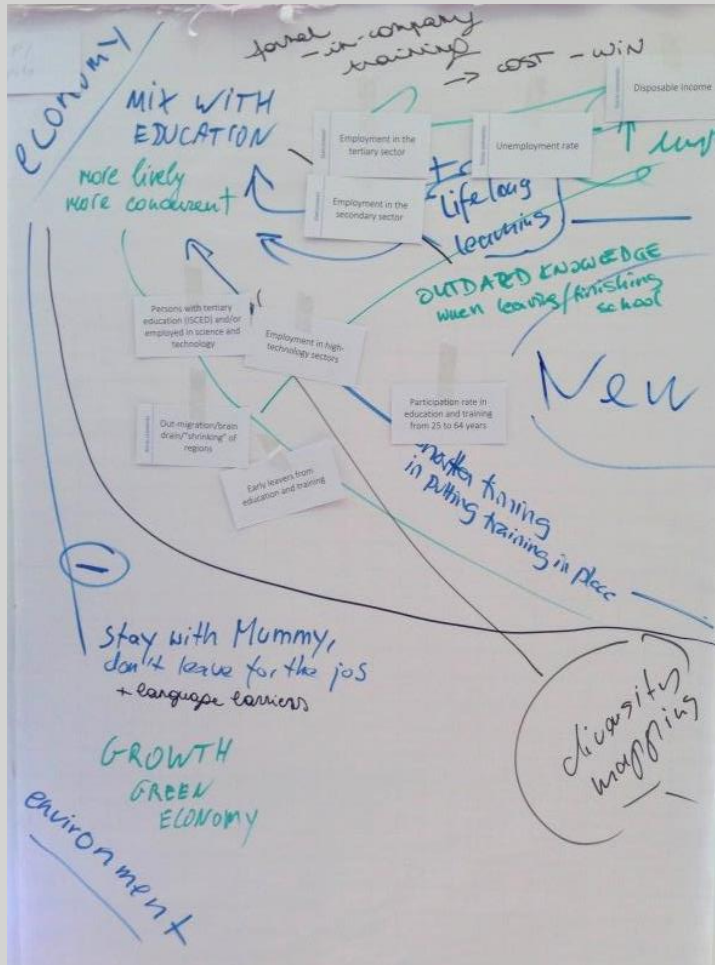

Systemic Picture

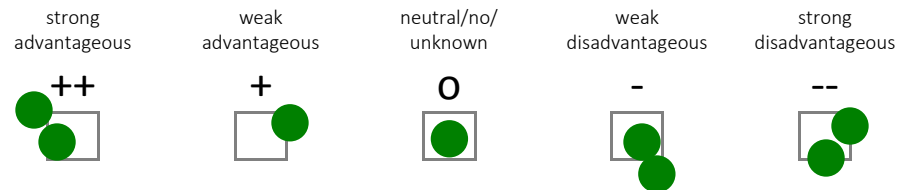

Other indicators selected by the experts

Other indicators:

- Participation rate in education and training 25 to 64
- Young people neither in employment nor in education and training from 15 to 24 years
- Early leavers from education and training
- Unemployment rate
- People at risk of poverty or social exclusion
- Entrepreneurship (share of private enterprises)
- Persons with tertiary education (ISCED) and/or employed in science and technology
