from second Division of Audit Department, e.g., System Audit Division) of the Audit Department. The placement of the Audit department within the structure of MRDLG and direct subordination to the State Secretary ensures the proper independence and segregation of duties, which is also stipulated in its Regulation.

The functions have been separated and the agency controls all projects on the 1st level. It is done in the <u>Cross Border Project Control Unit</u>, which has separate functions in the agency. It is possible that other units of the agency take part in the projects, because these units have separate functions.

The agency set up the schedule (concrete dates) to the project partners for project's 6 months activities first level control. For the agency it takes 10 days to check and send the progress report to the project partner. In the case of opinion on progress report is negative; controllers approaching the project with so called "Controllers Opinion" and project partner have the rights to submit once again the missing documentation. The agency tries to follow three months principle.

The agency together with the ministry is planning to work on new methodology on regulations issued by Cabinet of Ministers. According to Art.16.2 of Regulation (EC) No 1080/2006 the agency guarantees that all first level control audits are carried out within 3 months.

Currently the agency together with the ministry has launched the tender for the preparation of a Handbook, which will describe first level control system and requirements for the project partners for each European Territorial Cooperation programme. This methodology will be used for the programming period 2007 – 2013 and will be available on programmes' web pages after national approval.

The agency has been asking INTERACT I programme to help us with advice and methodology about the 1st level control.

Audit department have to sep up the control system as required by Article 60 b) of the Regulation (EC) No 1083/2006 saying that verifying that the co-financed products and services are delivered and that the expenditure declared by the beneficiaries for operations has actually been incurred and complies with Community and national rules; verifications on-the-spot of individual operations may be carried out on a sample basis in accordance with the detailed rules to be adopted by the Commission in accordance with the procedure referred to in Article 103(3).

For years 2007 – 2008 1st level control for Lead partners/Project partners will be provided free of charge and will be paid by Member State. Information on 2009-1013 will be completed later.

In any case MRDLG confirms that the central control body will sign the individual project partners' control confirmations as well as the confirmation for the whole project (in case of Latvian Lead partners) for the period 2007-2013.
