



Map: Classification of European Regions





3. Population % Change 2000-2007 Capital & Second Tier Metro-regions






Population % Change 2000-2007 (contd.)




4. Employment in 000s 2007 Capital & Second Tier Metro regions






5. % of employment in financial intermediation; real estate, renting and business activities, 2007






% of employment in financial intermediation; real estate, renting and business activities, 2007 (contd.)






% of employment in financial intermediation; real estate, renting and business activities, 2007 (contd.)







8. EPO Patent Applications per million inhabitant 2006-7








9. Potential Accessibility by Air, 2006




